INTRODUCTION

In addition to the threats posed by COVID-19, other humanitarian crisis are currently deteriorating, notably in Venezuela and East Africa. An urgent response is needed to prevent more dramatic consequences.

Venezuela – EUR 50 million

In Venezuela, the political crisis has entered an acute phase since January 2020. With no political solution in sight, the socio-economic crisis has reached a new peak, affecting the population's ability to satisfy the most basic needs (undernourishment, no access to water, collapse of waste disposal systems, unaffordable access to hygiene items, discontinuation of regular vaccination programmes, children no longer attending school). Altogether, some 10 million people need humanitarian assistance inside the country.

The fallout of the crisis within the region has also multiplied. In February 2020, the number of people who have left Venezuela - heading towards Colombia, Peru, Ecuador, Brazil and other countries - reached 5 million, with a further increase expected by end 2020, according to the United Nations High Commission for Refugees (UNHCR) and International Organisation for Migration (IOM). Unofficial figures suggest that the numbers could already be well above 6 million.

EUR 50 million in commitment and payment appropriations is requested in addition to the EUR 14 million already programmed for this crisis for 2020. The additional funding will be used to provide urgent assistance in the key sectors where the most acute needs have been identified, notably health, protection, nutrition, education in emergencies, water and sanitation, psychosocial support. In a context of competing priorities for international funding and of a sensitive domestic political situation, only the EU is currently in a position to deliver unhindered humanitarian assistance inside Venezuela thanks to its network of partners on the ground and its acceptance by both parties involved in the political crisis.

Locust in East Africa – EUR 40 million

In Eastern Africa, a number of countries are facing an unprecedented desert locust infestation. This needs to be rapidly contained to avoid a major humanitarian catastrophe due to a massive deterioration in the already widespread severe food insecurity and malnutrition in the entire region. Somalia, Kenya and Ethiopia are the most affected countries. This is the worst crisis for Kenya in 70 years, and the worst crisis for Somalia and Ethiopia in 25 years. On 2 February 2020, Somalia, where control operations are more difficult, declared a national emergency. Six other countries, some of which contribute to food security in the region, are also affected, namely: Uganda, Tanzania, Sudan, Djibouti, Eritrea, and most recently South Sudan. 13,5 million severely food-insecure people live in areas currently infested, and this number is expected to increase due to the arrival of new swarms during the planting season in March and April.

EUR 40 million in commitment and payment appropriations is requested in addition to the EUR 5 million already programmed for this area for 2020. Funding will finance immediate food pre-positioning and food assistance, as well as livelihood support, seeds (for farmers) and fodder distribution (to protect livestock). Further support will go to the procurement of nutrition supplies, health and nutrition centres.

As of the beginning of March 2020, the overall implementation rate of commitment appropriations of the humanitarian aid chapter 23 02 was at 94,5% of available appropriations and the implementation in payment appropriations was at 14,4%. The Operational Reserve for Humanitarian aid currently stands at EUR 55 million and needs to be preserved to cater for other, smaller humanitarian emergencies or sudden disasters between now and year end.

The Commission has not been able to identify other available resources in Heading 4. Therefore, it requests the mobilisation of the Emergency Aid Reserve for a total of EUR 90 million in commitment and payment appropriations for the crises in Venezuela and East Africa.
