Subject:	Transfer of appropriations No DEC 14/2023 within Section III - Commission - of the general budget for 2023

1. On 27 September 2023, the Commission submitted to the Council proposal for transfer of appropriations No DEC 14/2023, in accordance with Article 31(1) of the Financial Regulation¹.

The purpose of this proposal is to transfer appropriations available on several administrative support lines to the operational lines for programmes under (sub-)headings 1 (*Horizon Europe, Connecting Europe Facility and Single Market Programme*), 2a (*Cohesion Fund*), 2b (*EU4Health, European Social Fund+, Rights and Values*), 3 (*LIFE*), 5 (*EDF Research, Military Mobility*) and 6 (*NDICI, Overseas countries and territories*), as recorded in document 13440/23.

2. The aim of the proposal is to transfer a total amount of EUR 56.67 million in both commitment and payment appropriations.
 3. The Budget Committee examined this proposal for a transfer at its meeting on 2 October 2023.
 4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations, as set out in document 13440/23, and
 - the draft letter in the ANNEX to that effect.
