1. The General Secretariat of the Council has been informed of the resignation of Mr Jacob JOHANSSON, as alternate member of the Management Board of the above Centre in the governments' representatives category (for Sweden).
2. Under Article 4 of Regulation (EU) 2019/128 of the European Parliament and of the Council establishing a European Centre for the Development of Vocational Training (Cedefop) and repealing Council Regulation (EEC) No 337/75 members of the Management Board are appointed by the Council.

3. In accordance with the usual procedure, the government of Sweden has nominated the following candidate for this seat for the remainder of the current term of office, ending on 31 March 2027:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/128 of the European Parliament and of the Council establishing a European Centre for the Development of Vocational Training (Cedefop) and repealing Council Regulation (EC) No 337/75<sup>1</sup>, and in particular Article 4 thereof,

Whereas:

- (1) In its Decision of 28 March 2023<sup>2</sup>, the Council appointed members and alternate members of the Management Board of the European Centre for the Development of Vocational Training for the period from 1 April 2023 to 31 March 2027.
- (2) A seat as alternate member in the governments' representatives category has fallen vacant as a result of the resignation of Mr Jacob JOHANSSON.
- (3) The government of Sweden has nominated a candidate for the vacant seat,
