THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 883/2004 of the European Parliament and of the Council of 29 April 2004 on the coordination of social security systems³, and in particular Article 75 thereof,

Whereas:

- (1) In its Decision of 21 September 2020⁴, the Council appointed members and alternate members of the Advisory Committee for the Coordination of Social Security Systems for the period ending on 19 October 2025.
- (2) A seat as member in the employers' representatives category has fallen vacant as a result of the resignation of Mr Rumen RADEV.
- (3) The government of Bulgaria has nominated a candidate for the vacant seat,
