Dear Colleagues,

An increasing number of asylum seekers have arrived since August 2023 from Russia to Finland. Thus far these persons have arrived through the border crossing points at Finland's Southeastern external land border, namely Nuijamaa and Vaalimaa. Since last week the number of arrivals has increased considerably.

Finnish authorities have clear indications of facilitation of illegal immigration where organized international criminal networks are involved. In recent months, the actions of the Russian authorities have noticeably changed, at least at the land border in Southeastern Finland. At this time adequate information has also been gathered to indicate that the Russian authorities are actively contributing to the phenomenon with their actions. The growth of the phenomenon is intensified by greater activity on different social media platforms.

On 16 November 2023, the Government decided based on section 16 of the Border Guard Act on decisive and firm action to further restrict entry into Finland from Russia in order to mitigate the situation. As of 18 November 2023, border crossing points of Vaalimaa, Nuijamaa, Imatra and Niirala will be closed to all traffic. At the Finnish-Russian land border, the possibility to apply for international protection will be concentrated to the border crossing points of Vartius and Salla. The new restrictions will enter into force on 18 November 2023 at 00.00 and will remain in force until 18 February 2024. The new restrictions aim to safeguard public order and national security. Finland has informed Russia on the decision with a verbal note.

Limiting the possibility to apply for international protection will be done only as to the extent necessary to manage the situation. Particular attention is paid to providing help to vulnerable persons. Finland continues to assess the effectiveness, necessity and proportionality of the measures taken at the external border with Russia in light of the development of the phenomenon and will adjust its response accordingly.
