The SCA confirmed the approval of the compromise package on geographical indications, agreed at the fourth trilogue on 24 October 2023, as set out in documents 14942/23 and 14570/23 ADD1.

The SCA also authorised the Presidency to send a letter to the European Parliament informing it that a first reading agreement could be reached on the Commission's proposal, provided that Parliament agreed to adopt its position in the form of the text reflecting the political agreement.
