

### Exploitation

- Galileo and EGNOS services provision and 24/7 operations – including management, operation, maintenance, improvement, evolution & protection of infrastructure
- GOVSATCOM hub and IRIS<sup>2</sup> preparation
- Space Surveillance and Tracking Front Desk as of July



#### Security

- · Security Accreditation
- Security Monitoring Center operations (GSMC)
- Governmental Service Provision
- Key contributor for the implementation EU Space Strategy for Security and Defence



#### Utilization

- Market development, communications, user uptake, applications, innovation
- Galileo, EGNOS, commercial use of Copernicus, GOVSATCOM - and soon IRIS2

### Galileo Achievements 2023

- More than 4 Billion Galileo enabled devices (2.4 Billions in 2021, and 3.5 Billions in 2022)
- 1st GNSS provider to deliver decimeter level High Accuracy Service globally and directly through the space signal in 01/23
- Publication of enhanced commitments of Open Service SDD
- Galileo Open Service upgrade: I/NAV feature enables faster positioning & improve navigation data robustness in challenging environments
- Authentication service Initial Operational Capability declared in 08/23, moving on step closer to Initial Service; Provision of test certificates with PKI infrastructure since 08/23
- Important progress on the Public Regulated Service, towards the Initial Operational Capability and on the User Segment Tools procured by EUSPA
- Provision of operational data by 4<sup>th</sup> Search and Rescue SAR/Galileo MEOLUT since 03/23
- New SAR/Galileo Site in Greenland, new Galieo Sensor Station in Wallis, and new Galileo telemetry and telecommand station in Kourou








# EGNOS services and 24/7 operations

- · First step of EGNOS Security Monitoring at GSMC is now operational
- Implementation of the new upgrade of EGNOS V2 in operations since 4 Nov, significantly improving robustness to solar storms; new station in Finland
- Maritime Safety of Life service declaration with EGNOS expected by Q1 2024
- EUSPA becomes the EGNOS Design and Production Organization as per new Single European Sky IR (EU) 2023/1768-69

## GOVSATCOM and IRIS<sup>2</sup>

- · GOVSATCOM Hub Innovation partnership procurement contracts awarded, kick-offs ongoing
- Support to the Commission for the selection of the Hosting Sites for the GOVSATCOM Hub and the IRIS2 Control Center
- Contributing to Commission's IRIS<sup>2</sup> Task Force on daily basis
- Publication of the EUSPA Secure SatCom report

# Space Surveillance and Tracking

#### SST Front Desk fully operational since the 1<sup>st</sup> of July

- Competences acquired and IT infrastructure built and running with SST applications (e.g. SST Portal) deployed in the operational environment at the GSMC-ES
- Service running nominally, incl. Helpdesk operations. Already 3 SST Taskforce activations for critical or high mediatic events
- Implementing Arrangement with the SST Partnership (15 MS) signed in July. Agency also participates to the 6 SST grants (Space Regulation and 5 Horizon Europe calls)

#### Security monitoring activities

 Awaiting appointment of the GSMC as the Security Monitoring Structure and the General Security Requirements approval. Preparatory work on-going

#### Services and User uptake

- User consultation Platform 7/11 with dedicated SST session with satellite operators to discuss user needs/future services e.g. public-basic and commercial-advanced
- Growing user community with the opening of the SST collision avoidance service to non EU users (approx. 100 satellites from non EU countries registered already)





  - Applications being evaluated: 28


