“The EU and its Member States are parties to the United Nations Economic Commission for Europe (UNECE) Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters of 25 June 1998 (the ‘Aarhus Convention’).

Member States should ensure that members of the public concerned, who have a sufficient interest or that maintain the impairment of a right in accordance with national law, have access to a review procedure before a court of law, or an independent and impartial body established by law, to challenge the substantive or procedural legality of the national restoration plans and any failures to act of the competent authorities, regardless of the role members of the public concerned have played during the process for preparing and establishing such national restoration plans. This shall be in line with the relevant case law of the Court of Justice of the European Union related to access to justice in environmental matters and in full respect of the obligations Member States have undertaken as parties to the Aarhus Convention (1).’

Statement by the Commission

“While supporting the overall compromise, the Commission regrets the proposed wording of Article 1(6) of the Data Act concerning the relationship between the scope of application of that Act and the Member States’ responsibility for national security, in particular the use of the phrase ‘areas that fall outside the scope of Union law’. Such wording is not aligned with Article 4(2) TEU and the case-law of the Court of Justice which that provision codifies, according to which measures adopted by the Member States for the purposes of safeguarding national security, defence and public security are not excluded from the application of EU law and that Member States taking such measures must comply with that law.^[1] Since secondary EU legislation cannot modify what is stated in primary legislation, in the opinion of the Commission, the current wording of Article 1(6) will give rise to legal uncertainty, since it could be seen as implying that measures adopted for national security purposes within the context of the Data Act fall outside the scope of EU law.”
