- 1. The General Secretariat of the Council has been informed of the resignation of Mr Stephen CURRAN as alternate member of the Management Board of the above agency in the governments' representatives' category (for Ireland).
- 2. Under Article 4 of Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94, members of the Management Board are appointed by the Council.

3. In accordance with the usual procedure, the government of Ireland has nominated the following candidate for this seat for the remainder of the current term of office, ending on 31 March 2027:

Having regard to Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94¹, and in particular Article 4 thereof,

Whereas:

- 1. By its Decision of 28 March 2023², the Council appointed members and alternate members of the Management Board of the European Agency for Safety and Health at Work for the period from 1 April 2023 to 31 March 2027.
- 2. A seat as alternate member in the governments' representatives' category has fallen vacant as a result of the resignation of Mr Stephen CURRAN.
- 3. The government of Ireland has nominated a candidate for the vacant seat,
