	Appointment of Mr Gerd WIEGEL, alternate member for Germany, in place of Ms Maria DIMCHEVA, who has resigned

- 1. <u>The General Secretariat of the Council</u> has been informed of the resignation of Ms Maria DIMCHEVA as alternate member of the above Committee in the trade unions' representatives' category (for Germany)
- 2. Under Article 24 of Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union, members and alternate members are appointed by the Council.

3. In accordance with the usual procedure, the Government of Germany has nominated the following candidate for the remainder of the current term of office, ending on 24 September 2024<sup>1</sup>:

Mr Gerd WIEGEL Referatsleiter Demokratie, Migrations und Antirassismuspolitik Deutscher Gewerkschaftsbund (DGB)

- 4. The Permanent Representatives Committee is therefore asked to recommend the Council to:
  - (a) <u>adopt</u>, as an "A" item, <u>the attached Council Decision</u> replacing an alternate member of the Advisory Committee on Freedom of Movement for Workers, and
  - (b) have the Decision <u>published</u>, for information, in the Official Journal of the European Union.

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union<sup>2</sup>, and in particular Articles 23 and 24 thereof.

### Whereas:

- (1) By its Decision of 20 September 2022<sup>3</sup>, the Council appointed members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2024.
- (2) A seat as alternate member in the trade unions' representatives' category has fallen vacant as a result of the resignation of Ms Maria DIMCHEVA.
- (3) The Government of Germany has submitted a nomination for the vacant seat,
