Subject: COUNCIL DECISION appointing four members and four alternate members, proposed by the Kingdom of Spain, of the Committee of the Regions

COUNCIL DECISION (EU) 2024/...

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 305 thereof,

Having regard to Council Decision (EU) 2019/852 of 21 May 2019 determining the composition of the Committee of the Regions¹,

Having regard to the proposals of the Spanish Government,

Whereas:

- (1) Pursuant to Article 300(3) of the Treaty, the Committee of the Regions is to consist of representatives of regional and local bodies who either hold a regional or local authority electoral mandate or are politically accountable to an elected assembly.
- (2) On 3 February 2020, the Council adopted Decision (EU) 2020/144¹, appointing the members and alternate members of the Committee of the Regions for the period from 26 January 2020 to 25 January 2025. On 28 June 2022, the Council adopted Decision (EU) 2022/1043² appointing a member and two alternate members, proposed by the Kingdom of Spain, of the Committee of the Regions.
- (3) Four members' seats on the Committee of the Regions have become vacant following the resignations of Mr Abel Ramón CABALLERO ÁLVAREZ and Mr José María GARCÍA URBANO, and the end of the national mandate on the basis of which Mr Jorge Antonio AZCÓN NAVARRO and Mr Julio MILLÁN MUÑOZ were proposed for appointment.
- (4) Four alternate members' seats on the Committee of the Regions have become vacant following the resignations of Mr Manuel GARCÍA FÉLIX and Ms Noelia María ARROYO HERNÁNDEZ, and the end of the national mandate on the basis of which Ms Lidia MUÑOZ CÁCERES and Mr Óscar PUENTE SANTIAGO were proposed for appointment.

- (5) The Spanish Government has proposed the following representatives of local bodies who hold a local authority electoral mandate as members of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2025: Mr Jaume COLLBONI CUADRADO, *Alcalde de Barcelona* (Mayor of Barcelona), Ms Carolina DARIAS SAN SEBASTIÁN, *Alcaldesa de Las Palmas de Gran Canaria* (Mayoress of Las Palmas de Gran Canaria Council), Ms María José GARCÍA-PELAYO JURADO, *Alcaldesa de Jerez de la Frontera* (Mayoress of Jerez de la Frontera Council), and Mr José Luis MARTÍNEZ ALMEIDA NAVASQUÉS, *Alcalde de Madrid* (Mayor of Madrid Council).
- (6) The Spanish Government has proposed the following representatives of local bodies who hold a local authority electoral mandate as alternate members of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2025: Mr Xavier GARCÍA ALBIOL, *Alcalde de Badalona* (Mayor of Badalona Council), Ms Gema IGUAL ORTIZ, *Alcaldesa de Santander* (Mayoress of Santander Council), Mr Carlos MARTÍNEZ MÍNGUEZ, *Alcalde de Soria* (Mayor of Soria), and Ms Inés REY GARCÍA, *Alcaldesa de A Coruña* (Mayoress of A Coruña Council),

HAS ADOPTED THIS DECISION:

Article 1

The following representatives of local bodies who hold an electoral mandate are hereby appointed to the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2025:

(a) as members:

- Mr Jaume COLLBONI CUADRADO, *Alcalde de Barcelona* (Mayor of Barcelona),
- Ms Carolina DARIAS SAN SEBASTIÁN, *Alcaldesa de Las Palmas de Gran Canaria* (Mayoress of Las Palmas de Gran Canaria Council),
- Ms María José GARCÍA-PELAYO JURADO, *Alcaldesa de Jerez de la Frontera* (Mayoress of Jerez de la Frontera Council),
- Mr José Luis MARTÍNEZ ALMEIDA NAVASQUÉS, *Alcalde de Madrid* (Mayor of Madrid Council),

and

(b) as alternate members:

- Mr Xavier GARCÍA ALBIOL, *Alcalde de Badalona* (Mayor of Badalona Council),
- Ms Gema IGUAL ORTIZ, *Alcaldesa de Santander* (Mayoress of Santander Council),
- Mr Carlos MARTÍNEZ MÍNGUEZ, *Alcalde de Soria* (Mayor of Soria)
- Ms Inés REY GARCÍA, *Alcaldesa de A Coruña* (Mayoress of A Coruña Council).

Article 2
