I. EXPLANATORY BACKGROUND

1. The Working Party in Civil Law Matters (General Questions) wishes to bring to the attention of Coreper the question of the European Union's position to the accession of Azerbaijan to the Hague Convention of 23 November 2007 on the International Recovery of Child Support and Other Forms of Family Maintenance (hereafter 'the 2007 Hague Convention').

In accordance with articles 1 and 2 of the Protocol on the position of Denmark annexed to the Treaty on European Union and the Treaty on the Functioning of the European Union, Denmark does not take part in the establishment of the EU's position.

II. THE 2007 HAGUE CONVENTION

- 2. With regard to the 2007 Hague Convention, the Union has exclusive external competence, pursuant to Article 3(2) TFEU, insofar as the provisions of the Convention may affect or alter the scope of common EU rules on maintenance obligations².
- 3. The EU is a full contracting party to this Convention, which entered into force for the Union on 1 August 2014.
- 4. Pursuant to Article 58 (3) of the Convention, any third State can accede. However, according to Article 58(5) of the Convention, such accession shall have effect only as regards the relations between the acceding State and those Contracting States which have not raised an objection to its accession in the 12 months after the date of the notification of the accession to the depositary.
- 5. The Depositary notified Azerbaijan's accession to the 2007 Hague Convention on 27 February 2023. The twelve-months deadline for any objection to the proposed accession expires on **27 February 2024**.³
- 6. According to the Commission's information, which was put forward in ST 16997/23 and updated orally⁴ in the Working Party on Civil Law matters (General Questions) on 19 January 2024, while problems in relation to the protection of human rights and fundamental freedoms are to be noted, the Justice system appears capable of ensuring proper application of the Convention.
- 7. The two policy options as resulting from the 2007 Hague Convention are: (a) No objection to an accession; (b) Objection to an accession.

The initial Commission written assessment was updated afterwards and set out in ST 16997/1/23 REV 1.

III. SUMMARY OF THE CONTRIBUTIONS BY THE WORKING PARTY ON CIVIL LAW MATTERS AND ITS RECOMMENDATION ON THE ACCESSION OF AZERBAIJAN

- 8. The Working Party on Civil Law Matters (General Questions) discussed the accession of Azerbaijan to the 2007 Hague Convention on 19 January and 9 February 2024 and did not identify any fundamental obstacles related to the civil law area which could lead to an objection to the accession. The Commission shares the same views.
- 9. The Working Party on Civil Law Matters (General Questions), therefore, is recommending to Coreper that the European Union should not raise an objection to the accession of Azerbaijan to the 2007 Hague Convention.
- 10. This recommendation to approve a line to be taken in the case of Azerbaijan is without prejudice to the procedure to be followed in the future to establish the European Union's position concerning the accession of third States to such Hague Conventions which have the same accession mechanism as the 2007 Hague Convention.

IV. CONCLUSION

11. The Permanent Representatives Committee is therefore invited to recommend that the Council approve that the line to be taken by the European Union is not to raise an objection to Azerbaijan's accession to the 2007 Hague Convention.
