Subject:	Management Board of the European Foundation for the Improvement of Living and Working Conditions Appointment of Ms Sintija SĒJĒJA, alternate member for Latvia, in place of Ms Inese STEPĪŅA, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Ms Inese STEPĪŅA as alternate member of the Management Board of the above Foundation in the employers' representatives' category (for Latvia).
2. Under Article 4 of Regulation (EU) 2019/127 of the European Parliament and of the Council establishing the European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75¹, members of the Management Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2019/127 of the European Parliament and of the Council of 16 January 2019 establishing the European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75², and in particular Article 4 thereof,

Whereas:

- (1) By its Decision of 28 March 2023³, the Council appointed members and alternate members of the Management Board of the European Foundation for the Improvement of Living and Working Conditions for the period from 1 April 2023 to 31 March 2027.
- (2) A seat as alternate member in the employers' representatives category has fallen vacant as a result of the resignation of Ms Inese STEPINA.
- (3) The employers' organisation BusinessEurope has nominated a candidate for the vacant seat,

HAS ADOPTED THIS DECISION:
