In recital (6):

for:

‘It is necessary to provide economic operators with sufficient time to adapt to the new requirements. The application of this Delegated Regulation should therefore be deferred,’

read:

‘It is necessary to provide economic operators with sufficient time to adapt to the new requirements. The application of this Regulation should therefore be deferred.’

In the recitals, the following recital (7) is added after recital (6):

‘(7) In order to avoid unnecessary administrative burden and its related cost on economic operators, it is also necessary to provide for a sufficient transitional period after the entry into force of this Regulation during which equipment used outdoors already placed on the market which complies with Annex III to Directive 2000/14/EC may still be made available on the market,’

In Article 2, second paragraph:

for:

‘It shall apply from [Note to PO: insert exact date – [...] 24 months after entry into force of this Regulation].’

read:

‘It shall apply from [Note to PO: insert exact date – [...] 12 months after entry into force of this Regulation].’

In the Annex, in the introduction, in the first sentence of the last paragraph:

for:

‘For equipment listed in Article 12, where the use of the noise measurement methods laid down in this Annex or those laid down in the version of Annex III that was applicable [Note to PO: please insert the date of application],’

read:

‘For equipment listed in Article 12, where the use of the noise measurement methods laid down in this Annex or those laid down in the version of Annex III that was applicable before *[Note to PO: please insert the date of application]*’,

In the Annex, in Part A, in point 1.1(c), first paragraph:

for:

‘A fan that can work at continuous variable speed shall be tested in accordance with point 2.1(b) or with the fan speed set at no less than 70 % of the maximum speed.’

read:

‘A fan that can work at continuous variable speed shall be tested in accordance with point 1.1(b) or with the fan speed set at no less than 70 % of the maximum speed.’
