3. the adoption of the draft Regulation of the European Parliament and of the Council establishing the Ukraine Facility, as set out in PE-CONS 10/24;
4. the approval of the accompanying draft joint statement by the European Parliament and the Council and the draft joint statement by the European Parliament, the Council and the Commission as set out in ST 6712/24 ADD 2;
5. the adoption of the draft Regulation of the European Parliament and of the Council establishing the Strategic Technologies for Europe Platform ('STEP'), and amending Directive 2003/87/EC and Regulations (EU) 2021/1058, (EU) 2021/1056, (EU) 2021/1057, (EU) No 1303/2013, (EU) No 223/2014, (EU) 2021/1060, (EU) 2021/523, (EU) 2021/695, (EU) 2021/697 and (EU) 2021/241, as set out in PE-CONS 11/24.
