Subject:	Transfer of appropriations No DEC 02/2024 within Section III - Commission - of the general budget for 2024 – <i>Approval</i> – <i>Approval of a letter</i>

1. On 29 February 2024, the Commission submitted to the Council proposal for transfer of appropriations No DEC 02/2024 related to the mobilisation of the European Globalisation Adjustment Fund (EGF/2023/003 DE/Vallourec)¹, in accordance with Article 31(1) of the Financial Regulation².
2. As recorded in document 7099/24, the purpose of this proposal is to transfer an amount of 2 984 627 in commitment appropriations from Article 30 04 02 (*Reserve for the European Globalisation Adjustment Fund for Displaced Workers (EGF)*) to Article 16 02 02 (*European Globalisation Adjustment Fund for Displaced Workers (EGF)*).
