- (b) derogate, on the basis of the second subparagraph of Article 3(3) of the Council's Rules of Procedure, from the eight-week period referred to in the first subparagraph of that Article, in view of the urgency of the matter as set out in the preamble of that act;

Please answer "YES", "NO" or "ABSTAIN" to points (a) and (b) separately.

- (2) the adoption of the Decision of the European Parliament and of the Council on the mobilisation of the Flexibility Instrument to finance immediate budgetary measures in the context of the COVID-19 outbreak and a reinforcement of the European Public Prosecutor's Office, related to DAB No 1/2020, as set out in the Annex to document 7151/20;

Please answer "YES", "NO" or "ABSTAIN".

- (3) the adoption of the Council Regulation activating the emergency support under Regulation (EU) 2016/369, and amending its provisions taking into account the COVID-19 outbreak, as set out in document 7169/1/20 REV 1 + REV 1 COR 1 (as finalised by the legal linguistic experts);

- (4) (a) the adoption of the Council's position on draft amending budget No 2 to the general budget of the Union for 2020 (DAB No 2/2020) as set out in document 7201/20, and
- (b) derogate, on the basis of the second subparagraph of Article 3(3) of the Council's Rules of Procedure, from the eight-week period referred to in the first subparagraph of that Article, in view of the urgency of the matter as set out in the preamble of that act;

Please answer "YES", "NO" or "ABSTAIN" to points (a) and (b) separately.

- (5) the adoption of the Decision of the European Parliament and of the Council on the mobilisation of the Flexibility Instrument to finance immediate budgetary measures in the context of the COVID-19 outbreak, related to DAB No 2/2020, as set out in the Annex to document 7202/20;

Please answer "YES", "NO" or "ABSTAIN".

- (6) the adoption of the Decision of the European Parliament and of the Council on the mobilisation of the Contingency Margin in 2020 to provide emergency assistance to Member States and further reinforce the Union Civil Protection Mechanism/rescEU in response to the COVID-19 outbreak, related to DAB No 2/2020, as set out in the Annex to document 7204;

- (7) request the consent of the European Parliament on the draft Council Regulation (EU, Euratom) amending Regulation (EU, Euratom) No 1311/2013 laying down the multiannual financial framework for the years 2014-2020 as regards the scope of the Global Margin for Commitments, as set out in document 7170/20 (as finalised by the legal linguistic experts).
