  - (b) derogate, on the basis of the second subparagraph of Article 3(3) of the Council's Rules of Procedure, from the eight-week period referred to in the first subparagraph of that Article, in view of the urgency of the matter as set out in the preamble of that act;

Please answer "YES", "NO" or "ABSTAIN" to points (a) and (b) separately.

(2) the adoption of the Decision of the European Parliament and of the Council on the mobilisation of the Flexibility Instrument to finance immediate budgetary measures in the context of the COVID-19 outbreak and a reinforcement of the European Public Prosecutor's Office, related to DAB No 1/2020, as set out in the Annex to document 7151/20;
