Delegations are informed that the written procedure, opened by CM 2021/20 + COR 1 of 9 April 2020 and CM 2021/1/20 REV 1 of 14 April 2020 was completed on 14 April 2020 at 11:50 and that all delegations voted in favour of:

- (1) (a) the adoption of the Council's position on draft amending budget No 1 to the general budget of the Union for 2020 (DAB No 1/2020), as set out in document 7149/20, and
  - (b) the derogation, on the basis of the second subparagraph of Article 3(3) of the Council's Rules of Procedure, from the eight-week period referred to in the first subparagraph of that Article.

Therefore, the above position of the Council is adopted.

## Statement by Italy on the Council Regulation activating the emergency support under Regulation (EU) 2016/369, and amending its provisions taking into account the **COVID-19 outbreak**

"In relazione al documento 7169/1/20 REV1, relativo al Regolamento del Consiglio che attiva il sostegno di emergenza a norma del Regolamento (UE) 2016/369 e che ne modifica disposizioni in considerazione dell'epidemia di COVID-19, <u>l'Italia</u> richiama la necessità che le azioni finanziate dal Regolamento siano concordate dalla Commissione europea con i Paesi beneficiari, in particolare in merito all'identificazione delle priorità e degli attori idonei alla relativa attuazione. L'Italia invita la Commissione europea ad assicurare che tali azioni rientrino nel coordinamento generale attuato dai Paesi beneficiari per fronteggiare l'emergenza epidemiologica da COVID-19."

"With reference to document 7169/1/20 REV 1, related to the Council Regulation activating the emergency support under Regulation (EU) 2016/369, and amending its provisions taking into account the COVID-19 outbreak, Italy recalls the need for the actions financed by the Regulation to be agreed by the European Commission with the beneficiary Countries, in particular for what concerns the identification of the priorities and of the actors for their implementation. Italy invites the European Commission to ensure that these actions fall within the general coordination implemented by the beneficiary Countries in order to address the COVID-19 emergency."
