Subject:	Draft DIRECTIVE OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on a single application procedure for a single permit for third-country nationals to reside and work in the territory of a Member State and on a common set of rights for third-country workers legally residing in a Member State (recast) (first reading) - Adoption of the legislative act

- 1. On 28 April 2022 the <u>Commission</u> submitted its proposal¹, based on Article 79(2) points (a) and (b) TFEU, to the Council.
- 2. The European Economic and Social Committee delivered its opinion on 26 October 2022².
- 3. The European Committee of the Regions delivered its opinion on 30 November 2022³.
- 4. On 13 March 2024 the <u>European Parliament</u> adopted its position at first reading on the Commission proposal. The outcome of voting in the European Parliament reflects the compromise agreement reached between the institutions and should, therefore, be acceptable to the Council⁴.

- 5. The <u>Permanent Representatives Committee</u> is therefore asked to confirm its agreement and to suggest that the <u>Council</u>⁵ approve the European Parliament's position, as set out in <u>PE-CONS 93/23</u>, as an "A" item at a forthcoming meeting, with <u>Hungary</u> voting against and the <u>Czech Republic</u> and <u>Croatia</u> abstaining.
- 6. The statement for the minutes of the Council meeting is set out in the <u>Addendum</u> to this note.
- 7. If the <u>Council</u> approves the European Parliament's position, the legislative act will be adopted.

After being signed by the Presidents of the European Parliament and of the Council, the legislative act will be published in the *Official Journal of the European Union*.

In accordance with Articles 1 and 2 of the Protocol No 22 on the position of Denmark, annexed to the TEU and to the TFEU, Denmark is not taking part in the adoption of this Directive and is not bound by it or subject to its application.
