THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94², and in particular Article 4 thereof,

Whereas:

- 1. By its Decision of 28 March 2023³, the Council appointed members and alternate members of the Management Board of the European Agency for Safety and Health at Work for the period from 1 April 2023 to 31 March 2027.
- 2. A seat as member in the governments' representatives' category has fallen vacant as a result of the resignation of Mr Carlos ARRANZ CORDERO.
- 3. The government of Spain has nominated a candidate for the vacant seat,
