THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 305 thereof,

Having regard to the proposal of the Dutch Government,

Whereas:

- (1) On 10 December 2019, 20 January 2020, 3 February 2020 and 26 March 2020, the Council adopted Decisions (EU) 2019/2157<sup>1</sup>, 2020/102<sup>2</sup>, 2020/144<sup>3</sup> and 2020/511<sup>4</sup> appointing the members and alternate members of the Committee of the Regions for the period from 26 January 2020 to 25 January 2025.
- (2) Two alternate members' seats have become vacant following the end of the terms of office of Ms Christianne VAN DER WAL – ZEGGELINK and Mr Johannes Gerrit KRAMER,
