Subject:	Draft REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL amending Regulation (EU) 2016/399 on a Union Code on the rules governing the movement of persons across borders (first reading) - Adoption of the legislative act

1. On 14 December 2021 the Commission submitted its proposal¹, based on Article 77(2), points (b) and (e), and Article 79(2), point (c) TFEU, to the Council.
2. The European Economic and Social Committee delivered its opinion on 18 May 2022².
3. The Committee of the Regions delivered its opinion on 12 October 2022³.
4. On 24 April 2024 the European Parliament adopted its position at first reading on the Commission proposal⁴. The outcome of voting in the European Parliament reflects the compromise agreement reached between the institutions and should, therefore, be acceptable to the Council.

5. The Permanent Representatives Committee is therefore asked to confirm its agreement and to suggest that the Council⁵ ⁶ approve the European Parliament's position, as set out in PE-CONS 40/24, as an "A" item at a forthcoming meeting, with Spain and Slovenia abstaining.
6. The statements for the minutes of the Council meeting are set out in the Addendum to this note.
7. If the Council approves the European Parliament's position, the legislative act will be adopted.

After being signed by the Presidents of the European Parliament and of the Council, the legislative act will be published in the *Official Journal of the European Union*.
