<u>The Presidency</u> informed the SCA on the "Agriculture and Fisheries" Council meeting on 27 May 2024 and the next SCA meeting on 10 June 2024.

Regarding that Council meeting:

- <u>the Austrian delegation</u> requested an item under "any other business" on the "Challenges for agriculture and rural areas in the context of the increasing number of large carnivores";
- <u>the Romanian delegation</u> requested a public item under "any other business" on "Introducing the eligibility of expenses related to the purchase of breeding animals within the CAP Strategic Plans";
- <u>the Cyprus delegation</u> requested two public items under "any other business" on (1) drought and (2) the declaration of MED9 agriculture Ministers following their recent meetings; and
- <u>the Polish delegation</u> requested an item under "any other business" on the "difficult situation of fruit producers due to expected decline in yields caused by unfavorable weather conditions".

<u>The SCA</u> agreed that the AOB items requested by the Romanian and Cyprus delegations would be taken in public session in accordance with Article 8(2) of the rules of procedure of the Council.
