THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 186 and 212, in conjunction with Article 218(6), second subparagraph, point (a), thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament¹,

Whereas:

- (1) In accordance with Council Decision (EU) 2024/...², the Agreement between the European Union, of the one part, and Canada, of the other part, on the participation of Canada in Union programmes ('the Agreement') was signed on behalf of the Union on ...+, subject to its conclusion at a later date.
- (2) Horizon Europe the Framework Programme for Research and Innovation (2021-2027) was established by Regulation (EU) 2021/695 of the European Parliament and of the Council³. In line with the Council's mandate, the Protocol on the association of Canada to Horizon Europe the Framework Programme for Research and Innovation (2021-2027) was negotiated in parallel to the Agreement and, pursuant to Article 19(14) of the Agreement, forms an integral part thereof.
- (3) The Agreement should be approved.
- (4) In accordance with the Treaties, the Commission should make the notification provided for in Article 19(1) of the Agreement,

Regulation (EU) 2021/695 of the European Parliament and of the Council of 28 April 2021 establishing Horizon Europe – the Framework Programme for Research and Innovation, laying down its rules for participation and dissemination, and repealing Regulations (EU) No 1290/2013 and (EU) No 1291/2013 (OJ L 170, 12.5.2021, p. 1).

Article 1

The Agreement between the European Union, of the one part, and Canada, of the other part, on the participation of Canada in Union programmes ('the Agreement') is hereby approved on behalf of the Union⁴⁺.

Article 2

The Commission shall proceed, on behalf of the Union, to make the notification provided for in Article 19(1) of the Agreement, in order to express the consent of the Union to be bound by the Agreement⁵.

Article 3

This Decision shall enter into force on the date of its adoption.
