The Mission of the Kingdom of Norway to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honor to refer to the Agreement between the Council of the European Union and the Republic of Iceland and the Kingdom of Norway concerning the latter's association with the implementation, application and development of the Schengen acquis, signed on 18 May 1999.

The Mission of the Kingdom of Norway to the European Union refers to the adoption of the following act by the European Parliament and the Council of the European Union:

- *Regulation (EU) 2018/1862 of the European Parliament and of the Council of 28 November 2018 on the establishment, operation and use of the Schengen Information System (SIS) in the field of police cooperation and judicial cooperation in criminal matters, amending and repealing Council Decision 2007/533/JHA, and repealing Regulation (EC) No 1986/2006 of the European Parliament and of the Council and Commission Decision 2010/261/EU*

In accordance with Article 8 paragraph 2 (a) of the Agreement, the Mission of the Kingdom of Norway to the European Union hereby notifies, on behalf of the Government of Norway, that Norway has accepted the content of the said regulation.
