NOTE VERBALE

The Mission of Norway to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honor to refer to the Agreement between the Council of the European Union and the Republic of Iceland and the Kingdom of Norway concerning the latter's association with the implementation, application and development of the Schengen acquis, signed on 18 May 1999.

The Mission of Norway to the European Union refers to the adoption of the following Regulations by the European Parliament and the Council of the European Union:

- *Regulation (EU) 2023/2667 of the European Parliament and of the Council of 22 November 2023 amending Regulations (EC) No 767/2008, (EC) No 810/2009 and (EU) 2017/2226 of the European Parliament and of the Council, Council Regulations (EC) No 693/2003 and (EC) No 694/2003 and Convention implementing the Schengen Agreement, as regards the digitalisation of the visa procedure*
- *Regulation (EU) 2023/2685 of the European Parliament and of the Council of 22 November 2023 amending Council Regulation (EC) No 1683/95 as regards the digitalisation of the visa procedure*

In accordance with Article 8 paragraph 2 (a) of the Agreement concluded by the Council of the European Union and the Republic of Iceland and the Kingdom of Norway concerning the latter's association with the implementation, application and development of the Schengen acquis, the Mission of Norway to the European Union hereby notifies, on behalf of the Government of Norway, that Norway has accepted the content of the said regulations and that, according to Article 8 paragraph 2 (c), the content of these acts can become binding on Norway only after the fulfilment of constitutional requirements.

The Mission of Norway to the European Union avails itself of this opportunity to renew to the General Secretariat of the Council of the European Union the assurances of its highest consideration.
