



#### STATEMENT BY ESTONIA

"Estonia supports the goal of the Council Conclusions to facilitate better and more comparable measurement of economic effects of labour market, skills and social policies at the national level. Whereas stressing, that such quantifying assessments must remain voluntary.

While certain social policies will undoubtedly foster macroeconomic stability, it is crucial to maintain a balance between social welfare spending and long-term fiscal sustainability in the EU (and in the euro area).

Therefore, the intention of any future work stemming from the Conclusions should not be to weaken the implementation of the EU's economic and fiscal governance rules. In particular, it should not encourage Member States to create new and undefined concepts – such as social investments – that could potentially be used to extend the fiscal adjustment periods of any Member State. Introducing at EU level such approaches, that are not supported by evidence-based methodologies, would particularly serve the interests of Member States with high social protection expenditure and high unsustainable public debt levels, which would undermine the effective implementation of EU's fiscal and budgetary rules and safeguarding the ultimate aim of the Stability and Growth Pact.

Moreover, all discussions regarding the implementation of the economic governance rules should stay in the remits of ECOFIN."

#### STATEMENT BY IRELAND

"Ireland is fully supportive of the European Pillar of Social Rights, which provides a comprehensive framework of 20 principles that guide EU and national policies in the areas of Equal opportunities and access to the labour market; Fair working conditions; and Social protection and inclusion. Ireland is fully committed to strengthening implementation of the Pillar principles.

The Irish Constitution protects the right to freedom of association in Article 40.6.1°: 'The state guarantees liberty for the exercise of the following rights, subject to public order and morality:

. . .

iii. the right of the citizens to form associations and unions. Laws, however, may be enacted for the regulation and control in the public interest of the exercise of the foregoing right.'

The system of industrial relations in Ireland is essentially voluntary in nature. There has been agreement on all sides that the terms and conditions of employment of workers is best determined by the process of voluntary collective bargaining between an employer or employers' association and one or more trade unions, without the intervention of the State.

The State's role in industrial relations has been largely confined to facilitating the collective bargaining process through establishing by legislation, institutions to assist in the resolution of disputes between employers and workers."

#### STATEMENT BY HUNGARY

"Hungary declares that the Commission's Communication on the 'a Union of Equality: Gender Equality Strategy 2020-2025' mentioned in the La Hulpe Declaration on the Future of the European Pillar of Social Rights should be interpreted with due regard to national competences and the specific circumstances in each Member State. In line with its national legislation and constitutional values enshrined in the Fundamental Law, Hungary interprets the concept of 'gender' as reference to 'sex' and the concept of 'gender equality' as reference to 'women and men shall have equal rights."

Ad "B" item 17: Conclusions on the Future of the European Health Union Approval

#### STATEMENT BY PORTUGAL AND SPAIN

"Portugal and Spain praise the efforts by the Belgian EU Council Presidency to create an ambitious and indispensable vision for the future of the European Health Union with the shared goal of caring for and protecting European citizens. Coordinated actions are key for national health systems' preparedness to address both existing and future health challenges. In this context, we have been committed to efforts to mitigate medicines shortages and their impacts on patients. We support the shared call on the European Commission to consider proposing a Critical Medicines Act. However, Portugal and Spain interpret the corresponding measures described in paragraph 73 in a non-restrictive manner. We believe that the Critical Medicines Act should be based on a thorough impact assessment that considers all relevant measures, including EU-level support instruments, that can help to strengthen EU production of critical medicinal products, while ensuring a level playing field among Member States. In this way, we can safeguard an equitable access to critical medicines and to Health for all citizens across all Member States."

#### STATEMENT BY HUNGARY

"Hungary recognises and promotes equality between men and women in accordance with the Fundamental Law of Hungary and the primary law, principles and values of the European Union, as well as commitments and principles stemming from international law. Equality between women and men is enshrined in the Treaties of the European Union as a fundamental value. In line with these and its national legislation, Hungary interprets the term 'gender' as a reference to sex and the concept of 'gender equality' as reference to 'providing equal rights and opportunities to women and men' in the draft Council Recommendation on vaccine-preventable cancers.
