The Mission of the Principality of Liechtenstein to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honour to refer to the notification by the Council of 17 May 2024, which reads as follows:

„In accordance with the Protocol signed between the European Union, the European Community, the Swiss Confederation and the Principality of Liechtenstein on the accession of the Principality of Liechtenstein to the Agreement between the European Union, the European Community and the Swiss Confederation on the Swiss Confederation's association with the implementation, application and development of the Schengen acquis, and with the first sentence of Article 5(2)(a) of the Protocol, the Principality of Liechtenstein is herewith notified of the adoption of the following acts:

Regulation of the European Parliament and of the Council establishing a return border procedure, and amending Regulation (EU) 2021/1148

Council Document: PE-CONS 17/24
Date of adoption: 14 May 2024

Regulation of the European Parliament and of the Council introducing the screening of third-country nationals at the external borders and amending Regulations (EC) No 767/2008, (EU) 2017/2226, (EU) 2018/1240 and (EU) 2019/817

Council Document: PE-Cons 20/24
Date of adoption: 14 May 2024

In accordance with Article 5(2)(a) and (b) of the Schengen Protocol and subject to the fulfilment of the constitutional requirements in Liechtenstein, the Mission of the Principality of Liechtenstein to the European Union has the honour to inform the General Secretariat of the Council of the European Union that the Principality of Liechtenstein accepts the content of the act, which was attached to the above mentioned notification

by the Council and forms part of this reply note, and will implement it in its internal legal order. In accordance with Article 5(2)(b) of the Protocol, the Principality of Liechtenstein will promptly notify the General Secretariat of the Council of the European Union upon fulfilment of the constitutional requirements.

This exchange of notes will enter into force on the date of the notification by the Principality of Liechtenstein of the fulfilment of its constitutional requirements.

The Mission of the Principality of Liechtenstein to the European Union avails itself of this opportunity to renew to the General Secretariat of the Council of the European Union the assurances of its highest considerations.
