The Mission of Iceland to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honor to refer to the Agreement concluded by the Council of the European Union and the Republic of Iceland and the Kingdom of Norway concerning the latter's association with the implementation, application and development of the Schengen Acquis, signed on 18 May 1999.

The Mission of Iceland to the European Union refers to the adoption of the following regulation by the European Parliament and the Council of the European Union:

**Regulation of the European Parliament and of the Council introducing the screening of third-country nationals at the external borders and amending Regulation (EC) No 767/2008 (EU) 2017/2226, (EU) 2018/1240 and (EU) 2019/817**

Council Document: PE-CONS 20/24

Date of adoption: 14 May 2024

In accordance with Article 8(2)(a) of the aforementioned Agreement, the Mission of Iceland to the European Union hereby notifies, on behalf of the Government of Iceland, that Iceland has accepted the content of the said regulation and that, according to Article 8(2)(b), the content of this act can become binding on Iceland only after the fulfilment of constitutional requirements. The Mission of Iceland to the European Union will make its notification under Article 8(2)(a) once those requirements have been fulfilled.

The Mission of Iceland to the European Union avails itself of this opportunity to renew to the General Secretariat of the Council of the European Union the assurances of its highest consideration.
