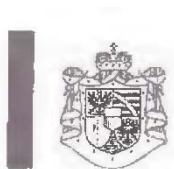

„In accordance with the Protocol signed between the European Union, the European Community, the Swiss Confederation and the Principality of Liechtenstein on the accession of the Principality of Liechtenstein to the Agreement between the European Union, the European Community and the Swiss Confederation on the Swiss Confederation's association with the implementation, application and development of the Schengen acquis, and with the first sentence of Article 5(2)(a) of the Protocol, the Principality of Liechtenstein is herewith notified of the adoption of the following act:

Regulation of the European Parliament and of the Council amending Regulation (EU) 2018/1806 as regards holders of Serbian passports issued by Serbian Coordination Directorate (Kordinaciona uprava)

Date of adoption: 22 July 2024"
