Delegations are hereby informed that the written procedure opened by CM 3986/24 of 6 September 2024 was successfully completed on 10 September 2024 at 12:00, and that all delegations voted in favour of:

CM 3987/24

- the adoption of the above-mentioned Council Decision on the signing and provisional application of the protocol, as set out in document ST 12474/24;
- agreement in principle on the above-mentioned Council Decision on the conclusion of the protocol, as set out in document ST 12475/24, and agreement to forward it, together with the text of the protocol (doc. 12189/24 + COR 1), to the European Parliament for its consent;
- the adoption of the above-mentioned Council Regulation on the allocation of fishing opportunities under the protocol, as set out in doc. 12448/24.

The required qualified majority has been reached. Therefore the Council Decision on the signing and provisional application of the protocol, as well as the Council Regulation on the allocation of fishing opportunities are adopted, agreement in principle has been reached on the Council Decision on conclusion, and the latter will be forwarded, together with the text of the protocol, to the European Parliament for its consent.

The Council has also taken note of statements by the Commission in doc. 12872/24 ADD 1. This statement will be included in the summary of acts adopted by the written procedure as a statement to be entered in the Council minutes, in accordance with the third subparagraph of Article 12(1) of the Council's Rules of Procedure.
