Subject:	Transfer of appropriations No DEC 08/2024 within Section III - Commission - of the general budget for 2023 – <i>Approval</i> – <i>Approval of a letter</i>

1. On 27 August 2024, the Commission submitted to the Council proposal for transfer of appropriations No DEC 08/2024 related to the mobilisation of the European Union Solidarity Fund¹, in accordance with Article 31(1) of the Financial Regulation².
2. The purpose of this proposal is to move an amount of EUR 796.76 million in commitment and payment appropriations from Item 30 04 01 01 (*European Solidarity Reserve*) to Item 16 02 01 01 (*Assistance to Member States in relation to events eligible under the European Union Solidarity Fund (EUSF)*).
