## **'I/A' ITEM NOTE**

Subject:	Council Decision appointing three members and seven alternate members, proposed by the Republic of Bulgaria, of the Committee of the Regions - Adoption

- 1. By letters of 27 November 2023<sup>1</sup>, 11 April 2024<sup>2</sup> and 29 July 2024<sup>3</sup>, the Secretary-General of the Committee of the Regions notified the Council of the resignations of Mr Ivan ALEKSIEV and Mr Emil IVANOV, members of the Committee of the Regions, and of Mr Daud ALYAOVLU, Ms Sebihan MEHMED and Ms Ivanka NIKOLOVA, alternate members of the Committee of the Regions, as well as the end of the mandates on the basis of which Ms Malina EDREVA AUDOIN, member of the Committee of the Regions and Ms Dimitranka KAMENOVA, Ms Cornelia MARINOVA, Mr Dobromir DOBREV and Mr Rumen PEHLIVANOV, alternate members of the Committee of the Regions, were proposed for appointment and appointed.
- 2. Under Article 305 TFEU, the Council appoints members and alternate members of the Committee of the Regions, acting by a qualified majority on proposals by the respective Member States.

In accordance with that provision and for the purpose of the replacement of Mr Ivan ALEKSIEV, Ms Malina EDREVA AUDOIN and Mr Emil IVANOV, the Bulgarian Government has proposed<sup>4</sup> the following representatives of local bodies who hold a local authority electoral mandate as members of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2025: Mr Dobrin DOBREV, Кмет на община Разград (Mayor of Razgrad Municipality), Mr Dimitar NIKOLOV, Кмет на община Бургас (Mayor of Burgas Municipality), and Ms Tsvetelina SIMEONOVA-ZARKIN, Общински съветник в Столичен общински съвет (Municipal Councillor in Sofia Municipal Council).
- 3.
