Thank you for your request for access to documents of the Council of the European Union.¹

Please find attached a partially accessible version of document **11373/24**.² However, I regret to inform you that full access cannot be given for the reasons set out below.

Document 11373/24 of 15 July 2024 is a note from the Presidency to the Working Party on External Aspects of Asylum and Migration (EMWP) containing the Overview of the Central-Mediterranean Route.

The redacted part of the text gives an indication of the internal elements and their attached weight in the reflection in the Council when cooperation with third countries is assessed and the specific priorities the European Union attaches to various indicators. Granting full access to such politically sensitive information would allow for comparison between the relations with different third countries, on internal priorities and on the rationale thereof. Whereas the information contained in

the partially accessible version of the document can be released to the public domain, all the information contained in the document is placed in a specific context where in addition to its simple operational values, it gives a clear indication of what are the driving factors for specific decisions and assessment in the exchanges in the Council.

Therefore, having duly consulted with the responsible political Directorate-General within the General Secretariat of the Council as well as the European Commission who is the originating source of the information related particularly to the cooperation with the third countries concerned, the General Secretariat of the Council is of the opinion that full disclosure of the information contained in the requested document would undermine the protection of the public interest as regards international relations. Consequently, the General Secretariat of the Council must refuse full access to document 11373/24.³

You may, however, have a partial access to the text of the document.

Pursuant to Article 7(2) of Regulation (EC) No 1049/2001, you may ask the Council to review this decision within 15 working days of receiving this reply. Should you see the need for such a review, you are invited to indicate the reasons thereof.

Thank you for your response, and I appreciate your decision to release parts of the document. Unfortunately, I find your decision to be unsatisfactory, and I would therefore like to file a confirmatory application.

Specifically, I find that your response failed to show that there is a non-hypothetical and real harm to public security in the full release of the document. In your response, you speak of a "specific context" where the release of the information would have a detrimental effect on public security with regards to international relations. However, this justification is too hypothetical and not fully realistic in terms of the harm it could cause.

Therefore, I would like you to reconsider your decision, and release the remaining parts of the documents.
