Subject:	European Semester 2024: Council Recommendations on economic, budgetary, employment and structural policies of the Member States

Country-specific Recommendations (CSRs)

Under the European Semester, the Commission submitted on 19 June 2024 to the Council 27 Recommendations for Council Recommendations on the on the economic, social, employment, structural and budgetary policies of Member States.

These recommendations combine economic and employment recommendations, based on Articles 121(2) and 148(4) of the Treaty on the Functioning of the European Union (TFEU). They are in line with Regulation 2024/1263, which is in force since 30 April 2024, and, as applicable, with recommendations on the preventive part of the macroeconomic imbalances procedure under Article 6(1) of Regulation 1176/2011.

Following the preparatory process at the Committee level, and the approval by the Council on 16 July, the Council will proceed to the formal adoption of the final texts after the European Council has discussed a conclusion on the broad guidelines of the economic policies of the Member States and of the Union, in accordance with Article 121(2) TFEU.

Council Recommendations on economic, budgetary, employment and structural policies of the Member States as revised by legal-linguistic experts, are set out in the documents listed in the annex of this note.
