Whereas:

- (1) The Decision of the Representatives of the Governments of the Member States, meeting within the Council, of 7 June 2016 authorising the European Commission to negotiate, on behalf of the Member States, the provisions of a comprehensive air transport agreement between the European Union and its Member States and the Association of Southeast Asian Nations (ASEAN) Member States on matters that do not fall within the exclusive Union competence ("the Decision"), will expire on 7 June 2020.
- (2) Immediately after the adoption of the Decision, the Commission contacted each of the ASEAN Member States with a view to commencing negotations.
- (3) Eight rounds of negotiations have been held since November 2016.
- (4) Under the circumstances, it is unlikely that negotiations can be successfully concluded before the expiry of the authorisation conferred by the Decision.
- (5) It is therefore necessary to amend the Decision in order to extend that authorisation so as to allow the Commission, which could be assisted by the Council Presidency, to continue to conduct negotiations within a framework conducive to a successful conclusion.

(6) Considering the current state of the negotiations, the extension of the said authorisation to negotiate should be limited to a further period of one year. If the negotiations are not concluded by the end of that further period, it should be possible for the Representatives of the Governments of the Member States to decide to extend that authorisation further,

Article 1

Article 4 of the Decision of the Representatives of the Government of the Member States, meeting within the Council, of 7 June 2016 authorising the European Commission to negotiate, on behalf of the Member States, the provisions of a comprehensive air transport agreement between the European Union and its Member States and the Association of Southeast Asian Nations (ASEAN) Member States on matters that do not fall within the exclusive Union competence is replaced by the following:

"Article 4

This Decision shall expire on 7 June 2021. It may be extended to align it with the Council Decision of 7 June 2016 authorising the Commission to open negotiations on a comprehensive air transport agreement between the European Union and its Member States and the ASEAN Member States as regards matters falling within the exclusive Union competence."
