Regulation on CAP Strategic Plans

Exchange of views on financial flexibility and sectoral types of interventions

13159/19

The SCA exchanged views on Presidency drafting suggestions on financial flexibility and sectoral types of interventions set out in documents 13157/19 and 13159/19. The SCA also took note of delegations' and the Commission's comments.

The Presidency noted that there was broad support on the drafting suggestions on a number of points, including on a closed list for 'other sectors' in Art. 39(f) and Annex [X], and will incorporate them in a consolidated text.

The Presidency took note of the comments made on several Articles, particularly on Art. 88(3) related to indicative financial allocations and Art. 89(1) on variation of the unit amount. The Presidency also took note of the diverging opinions expressed by delegations on some points, particularly on Art. 47(2) related to national financial assistance and Article 60a on types of interventions and their implementation in other sectors.

Exchange of views

The SCA took note

- of the Commission reports on the exercise of the power to adopt delegated acts under the regulations on the Outermost regions and the smaller Aegean Islands, on Aromatised wines and on Information rules and promotion measures, and under the four main CAP regulations;
- that for the regulations on the Outermost regions and the smaller Aegean Islands, on Aromatised wines and on Information rules and promotion measures, the tacit extension of the delegation of powers for the Commission to adopt delegated acts is already in force;
- that, regarding the regulations on the support for rural development, on the financing, management and monitoring of the CAP, on the direct payments and on the common organisation of the markets, delegations can accept the tacit extension of the period of empowerment for an identical duration.

The Presidency informed the SCA about the next SCA meeting on 5 November 2019.
