THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union and in particular Article 100(2), in conjunction with Article 218(5) thereof,

Having regard to the Act of Accession of the Republic of Croatia, and in particular the second subparagraph of Article 6(2) thereof,

Having regard to the proposal from the European Commission,

Whereas:

- The Ancillary Agreement between the European Union and its Member States, of the first part, Iceland, of the second part, and the Kingdom of Norway, of the third part, on the application of the Air Transport Agreement between the United States of America, of the first part, the European Union and its Member States, of the second part, Iceland, of the third part, and the Kingdom of Norway, of the fourth part¹ (hereinafter the 'Ancillary Agreement') was signed on 16 and 21 June 2011.
- (2) In accordance with the second subparagraph of Article 6(2) of the Act of Accession of the Republic of Croatia², the accession of Croatia to the Ancillary Agreement is to be agreed by means of a Protocol to that Agreement, concluded between the Council, acting unanimously on behalf of the Member States, and Iceland and the Kingdom of Norway.
- (3) On 14 September 2012, the Council authorised the Commission to open negotiations with a view to concluding a Protocol amending the Ancillary Agreement to take account of the accession of Croatia to the European Union (hereinafter the 'Protocol').
- (4) The negotiations were successfully concluded and the Protocol was initialled on 8 March 2019.

(5) The Protocol should be signed and should be applied on a provisional basis in accordance with Article 4 thereof, subject to its conclusion at a later date, HAS ADOPTED THIS DECISION:

Article 1

The signing of the Protocol amending the Ancillary Agreement between the European Union and its Member States, of the first part, Iceland, of the second part, and the Kingdom of Norway, of the third part, on the application of the Air Transport Agreement between the United States of America, of the first part, the European Union and its Member States, of the second part, Iceland, of the third part, and the Kingdom of Norway, of the fourth part, signed on 16 and 21 June 2011, to take account of the accession to the European Union of the Republic of Croatia (hereinafter the 'Protocol'), is hereby authorised on behalf of the Union and its Member States, subject to the conclusion of the said Protocol.¹

Article 2

The President of the Council is hereby authorised to designate the person(s) empowered to sign the Protocol on behalf of the Union and its Member States.
