STATEMENT BY AUSTRIA

Declaration by Austria to the minutes of Coreper II: "Austria is strongly concerned by the Council calling on the Commission to re-engage in a discussion with the Member States regarding the need for a legislative limitation on cash payments at EU level, as foreseen in its communication of 7 May 2020 on an Action Plan on Money Laundering. Firstly, Austria would like to refer to the resolution of the lower chamber of the Austrian Parliament (National Council) of 24 February 2016 on the maintenance of the use of cash. Secondly, the Commission's communication on the Action Plan of 7 May 2020 in fact only refers to "Introducing a ceiling for large cash payments" (page 6 third paragraph), but not a ceiling for cash payments in general. Therefore, Austria would have welcomed further improvements of the respective passages of the current text of the Draft Council conclusions and an alignment with the Commission's Action Plan."

ITALIAN STATEMENT

"Draft Council Conclusions on enhancing financial investigations to fight serious and organised crime"

Italy shares the scope and the objectives of the "Draft Council Conclusions on enhancing financial investigations to fight serious and organised crime".

As far as the contents of the Conclusions are concerned (doc. 8605/20) Italy will make all efforts in their implementation, in accordance with the need to take into account the nature, powers, tasks and prerogatives of its national authorities and mechanisms, as established by its national law."

Italy highlights that its position is in coherence with its declaration (doc. 19313/19 ADD 1 REV 2; CODEC 1080 ENFOPOL 245 JAI 521 EF 194), on the occasion of the adoption of Directive 1153/2019 of the Parliament and of the Council laying down "rules facilitating the use of financial and other information for the prevention, detection, investigation or prosecution of certain criminal offences".
