Due to the COVID-19 pandemic, a number of files that were scheduled for discussion at the COSI SG meeting in May were processed by written proceedings under request for contributions as set out in CM 2092/20, as follows:

1. Information from the Presidency

2. EU Policy Cycle for Organised and Serious International Crime/EMPACT

2.1. Monitoring the implementation: NEC meeting conclusions, based on Europol's final findings and results of the comprehensive Drivers' reports on the OAPs 2019

Pursuant to amendments following the COSI SG written proceedings, the Presidency conclusions and recommendations regarding the implementation of the 2019 OAPs were revised to 7627/1/20 REV 1 and are thus considered as endorsed by COSI SG delegations.

Delegations took note of the factsheets of results of the 2019 Operational Action Plans of the EU policy cycle to tackle organised and serious international crime as set out in 7623/20, the drivers final reports, as listed in 7438/20 and of Europol's final findings on the implementation of the OAPs 2019, as well as the illustrative table of participants in the actions of the OAPs 2019 and the status of those actions, as set out in 7409/1/20 REV 1.

2.2. Mid-term assessment of the results of the operational actions to measure the achievement of the strategic goals

The Council conclusions on the continuation of the EU policy cycle 2018-2021 (7704/17) introduced this new level of monitoring and following the NEC meeting on 29-30 October 2019, Europol and the HR Presidency were tasked to prepare a template to be filled in by the drivers, co-drivers and action leaders. The version set out in 7628/1/20 REV 1 takes into account the written comments received from delegations and includes further refinements upon suggestions by delegations. The document is considered endorsed by COSI SG delegations.

2.3. Media communication - follow-up of the implementation in line with COSI guidance adopted on 15/5/2018

The revised version of the document, as set out in 7434/1/20 REV 1 takes into consideration comments received from NECs, as well as COSI SG delegates and is considered as endorsed by COSI SG delegations.

2.4. Funding - State of play of EU Policy Cycle Funding 2019 and 2020
