The SCA also noted that there is a qualified majority of delegations who support the Presidency suggested compromise text set out in the Annex to document 8732/2/20 REV 2.

The SCA therefore gave the Presidency a revised mandate for the third trilogue on 30 June on that basis.

The Presidency informed the SCA about the Informal Videoconference of Agriculture and Fisheries Ministers on 29 June, and the next SCA meeting on 30 June 2020.

- they plan to organise an "Agriculture and Fisheries" Council meeting on 20 July; and
- that the informal meeting of Agriculture Ministers, planned to take place in Koblenz at the end of August and beginning of September, would go ahead as planned but without holding a meeting of the SCA there.
