COUNCIL DECISION on the position to be taken on behalf of the European Union in the Council of the International Civil Aviation Organization in respect of the envisaged adoption of Amendment 91 to Annex 10, Volume III and on the notification of difference from the date of application of Amendment 13B to Annex 14, Volume 1, Amendment 40C to Annex 6, Amendment 77B to Annex 3 and Amendment 39B to Annex 15

Delegations are informed that the written procedure, opened by CM 2397/20 of 4 June 2020, was completed on 8 June 2020.

All delegations voted in favor. The result of the written procedure is that Council adopted the **Council decision on the position to be taken on behalf of the European Union in the Council of the International Civil Aviation Organization in respect of the envisaged adoption of Amendment 91 to Annex 10, Volume III and on the notification of difference from the date of application of Amendment 13B to Annex 14, Volume 1, Amendment 40C to Annex 6, Amendment 77B to Annex 3 and Amendment 39B to Annex 15**, as set out, after lawyer-linguistic revision, in document 8284/1/20 REV1¹.

The European Parliament will be informed about the adoption of the Council Decision.

The statement by France is reproduced in the Annex to this CM.

The above statement will be included in the summary of acts adopted by the written procedure as statements to be entered in the Council minutes, in accordance with the third subparagraph of Article 12(1) of the Council's Rules of Procedure.

Statement by France

Déclaration unilatérale française accompagnant la réponse française à la procédure écrite
(CM 2397/20)

"Dans la mesure où l'OACI s'achemine finalement vers un report d'un an des SARP concernant la sécurité des pistes, ce qui n'était pas encore figé lorsque la procédure de coordination de la position européenne a débuté, les autorités françaises, tout en approuvant la proposition de décision du Conseil, souhaitent que les représentants des États membres puissent faire preuve sur place de la souplesse nécessaire pour accepter un report supérieur à six mois si telle était la proposition faite lors du conseil de l'OACI pour avoir une échéance commune à l'Union européenne et au reste du monde. Il est en effet essentiel que ces normes internationales s'appliquent au même moment partout dans le monde."
