	Council Recommendation on the temporary restriction on non-essential travel into the EU and the possible lifting of such restriction
	- Adoption

Delegations are informed that the written procedure, opened by CM 2829/20 of 29 June 2020, was completed on 30 June 2020 at 15:15. The required qualified majority has been reached. Therefore, the Council Recommendation on the temporary restriction on non-essential travel into the EU and the possible lifting of such restriction as set out in document ST 9147/20 is adopted.

Statement of the Belgian Delegation

- Belgium choses a cautious approach regarding the implementation of the Recommendation.
- The following category of persons will be exempted from travel restrictions, independent of the purpose of travel, starting from July 1, but will have to respect a period of self-quarantine: Union citizens within the meaning of Article 20(1) TFEU and third-country nationals who, under agreements between the Union and its Member States, on the one hand, and those third countries, on the other hand, enjoy rights of free movement equivalent to those of Union citizens, as well as their respective family members.
- The enlargement of the list of categories considered as essential travel to study purposes will
 depend on the possibility to restart the visa procedures at the Consulates. Regarding the
 category of highly qualified third-country workers, this still needs to be discussed with the
 competent regional authorities.
- Regarding the list of third countries for which the restrictions of non-essential travel may be
 lifted: Belgium will a priori not lift the restrictions regarding the countries for which
 Belgium still has doubts. The restrictions will only be lifted when there is sufficient clarity
 and certainty.

Statement of the Slovenian Delegation

Slovenia would like to thank the Croatian Presidency and the European Commission for their efforts in preparing the EU coordinated approach regarding the lifting of the temporary restriction on non-essential travel to the EU. Slovenia supports such coordinated approach.

Slovenia understands that the purpose of the document and its annexes is to agree on the criteria and on the list of third countries with relatively favorable epidemiological situation, towards which travel restrictions could be lifted. However, Slovenia also understands that the member states can apply stricter criteria when assessing the risk posed by epidemiological situation in third countries, and adopt stricter regime in relation to travel from those countries if this is deemed necessary for containing the spread of Covid-19 on its territory, than anticipated in the Recommendations.
