d) Detailed grounds for the increase

A reinforcement is needed on this budget line to cover payments in the framework of an Agreement with Member States with a view to signing EU-level Advance Purchase Agreements with vaccine manufacturers (Commission decision adopted on 18 June 2020). The purpose of these Agreements is to develop and deploy an effective and safe vaccine against the virus COVID-19. On this basis, the Commission will run a single central procurement procedure on behalf of all Member States.

As emphasised in the Commission's strategy for COVID-19 vaccines adopted on 17 June 2020, a permanent solution to the current health crisis will most likely be brought about by the development and deployment of an effective and safe vaccine against the virus. In this context, it is of utmost importance to make the best use of all the available funding to support vaccine projects.
