The chair of the CCWP Experts gave an overview on the CCWP Experts' planning for the coming six months: CCWP in Experts format will operate through written procedure. Main topics will be:

- \* CCWP Action Plan alignment with EMPACT
- \* Institutionalisation of the annual Heads of CCUs meeting
- \* Implementation of the 10th Action Plan
- \* Joint session with DUWP on 10 November : (inter alia) Preparatory work on the future ECM and state of play of Stenfor

# 3. German Council Presidency programme in the CCWP

The Presidency presented its priorities for the coming six months.

The key aspects will be:

- Strengthening cooperation between Customs and other Law Enforcement
   authorities: Enhance combatting smuggling of illegal goods via postal traffic
- Aligning the CCWP and EMPACT action planning
- Joint session CCWP with Law Enforcement Working Party (LEWP)
- Consideration of Customs specific challenges and chances of the Belt and Road
   Initiative in the EU
- Advancing the cooperation between Customs and Export Control authorities
- Joint session of the CCWP and the Dual-use Working Party (DUWP)
- Strengthening the Central Coordination Units (CCUs) by institutionalising the annual Heads-meetings or giving it a permanent mandate

Virtual meetings will be held on 11 September (joint meeting CCWP-LEWP) and 10 November (joint meeting CCWP-DUWP). One physical meeting is planned for December.

# 4. CCWP Trio Presidency programme

The Portuguese delegation presented the CCWP Trio Presidency programme for the coming 18 months. The main objectives are:

- \* Enhancing Police, Customs & Judicial cooperation Increasing the contribution of Customs to Internal Security
- \* Strengthening the fight against terrorism and cross-border crime, improving cooperation with third countries
- \* External EU borders

#### 9. European Financial and Economic Crime Centre (EFECC)

Europol presented the newly established EFECC.

#### 10. Any other business

The Spanish delegation gave a brief presentation on the launch of Action 10.1.3.
