While taking note of the objection expressed by Lithuania, the <u>SCA</u> agreed to inform the Parliament and the Commission, prior to the expiry of the period for objecting, that the Council does not intend to raise objections, by submitting an "A" item note reflecting the intention of "early non-objection" to the Council meeting on 20 July 2020.
