Appointment of Ms Kristi SÕBER, member for Estonia, in place of Ms Eve PÄÄRENDSON, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Ms Eve PÄÄRENDSON, as member of the Management Board of the above Foundation in the employers' representatives category (for Estonia).
2. Under Article 4 of Regulation (EU) 2019/127 of the European Parliament and of the Council of 16 January 2019 establishing the European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75, members of the Management Board are appointed by the Council.

Having regard to Regulation (EU) 2019/127 of the European Parliament and of the Council of 16 January 2019 establishing the European Foundation for the improvement of living and working conditions (Eurofound)¹, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019² the Council appointed the members and alternate members of the Management Board of the European Foundation for the Improvement of Living and Working Conditions for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as member in the employers' representatives category has fallen vacant as a result of the resignation of Ms Eve PÄÄRENDSON.
- (3) The employers' organisation BusinessEurope has nominated a candidate for the vacant seat,
