gestützt auf den Beschluss (EU) 2019/853 des Rates vom 21. Mai 2019 zur Festlegung der Zusammensetzung des Europäischen Wirtschafts- und Sozialausschusses<sup>1</sup>,

gemäß den Vorschlägen der einzelnen Mitgliedstaaten,

nach Anhörung der Europäischen Kommission,

in Erwägung nachstehender Gründe:

- (1) Gemäß den Beschlüssen (EU, Euratom) 2015/1600<sup>1</sup> und (EU, Euratom) 2015/1790<sup>2</sup> des Rates ist die Amtszeit der derzeitigen Mitglieder des Europäischen Wirtschafts- und Sozialausschusses am 20. September 2020 abgelaufen. Daher sollten Mitglieder für einen Zeitraum von fünf Jahren ab dem 21. September 2020 ernannt werden.
- (2) Jeder Mitgliedstaat ist ersucht worden, eine Liste von Kandidaten bestehend aus Vertretern der Organisationen der Arbeitgeber und der Arbeitnehmer sowie anderen Vertretern der Zivilgesellschaft, insbesondere aus dem sozialen und wirtschaftlichen, dem staatsbürgerlichen, dem beruflichen und dem kulturellen Bereich, zur Ernennung zu Mitgliedern des Europäischen Wirtschafts- und Sozialausschusses, vorzulegen.
