The SCA exchanged views on several issues related to the CAP Strategic Plans Regulation on the basis of the Presidency note including drafting suggestions set out in document 11033/20.

The Presidency took note of the comments from delegations and the Commission and would further reflect on how to incorporate them with a view to reaching a General Approach at the October Council.

With regard to the Amending or CMO Regulation, the SCA exchanged views on the Presidency suggested amendments set out in document 10970/20 and took note of delegations' comments.

The Presidency noted that most delegations agreed that the text could be considered as stable.

In this respect the SCA authorised the Presidency to send a letter to the Chair of the European Parliament's AGRI Committee confirming that, if the European Parliament adopted the text at first reading, subject to the revision by the lawyer-linguists of both institutions, the Council would accept it.
